



# Rules & Regulations For Exhibitors

## Move-In and Set-up Indoor/Outdoor Vendors

Exhibitor spaces will be available for set-up from 8am until 8pm on Thursday to Noon on Friday, March 20th, 2020. Move-in hours will be strictly enforced for security purposes.

ALL EXHIBITORS MUST BE SET UP PRIOR TO NOON, FRIDAY, MARCH 20TH. NO EXCEPTIONS!

Racer move-in starts at noon on Friday, March 20th.

\*Special arrangements for early arrival can be made by calling the Right Coast office at 800-753-3978.

Indoor exhibitor fee includes space as well as pipe, drape and 110v electricity. On-site contracted exhibitor decoration services will be provided by Northeast Decorating & Exhibit Services, Inc., P.O. Box 607, Syracuse, NY 13209. A list of additional (optional) services and fees offered by this contractor can be obtained by calling (315) 471-9989.

Exhibitor display and merchandise must remain within the confines of the contracted space. Exhibitor materials must not overflow into the aisles. Distribution of literature and sales aids must take place within your assigned vendor space ONLY.

Booth space must be used solely by the company/person and for the products and services stipulated in the rental agreement. Subletting of space by exhibitors is strictly prohibited. FOOD & BEVERAGE sales will NOT be permitted. Any violation of contracted services will result in immediate removal without refund.

Exhibitors are always required to maintain a neat and orderly appearance. Right Coast reserves the right to remove any vendor not selling items listed on this application or deemed not family/show friendly by Right Coast, Inc. staff. All decisions are at the sole discretion of Right Coast, Inc., and final. NO REFUNDS.

### **Vendor Passes**

Vendor Passes as issued as follows: (2 passes – 600sf) (4 passes – 800sf and larger)

#### **Exhibit Hours**

Vendor and racer gates open at 7am each day. Spectator gates open at 10am each day.

#### Breakdown and Move-Out

Exhibitors will be required to remain open and operational until the last race on Sunday, March 22nd. (appox 5pm)

Display vehicles cannot be moved or started until the races end each day.

Move-out of buildings must be completed no later than 8pm Sunday, March 22nd, 2020.

#### Refunds

Refunds will be issued for cancellations made on or before March 1st, 2020. Full refunds for space cancellations will be made prior to March 1st, 2020 (less a \$25.00 administrative fee). Right Coast, Inc. reserves the right to cancel all unpaid reservations after March 1st, 2020.

## General Insurance Liability

Right Coast, Inc., its agents, representatives, sponsors or employees are not responsible for any injury, loss or damage that may occur to the exhibitor or the exhibitor's employees or property from any cause or condition.

#### Compliance & Enforcement

Right Coast, Inc. reserves the absolute right to remove any and all persons at its sole discretion without refund.

#### Security

Security is provided for the venue only. All participants are responsible for their own property (ie., vehicles, personal belongings, merchandise etc.) The security office is located at the registration table in the Pits Building.
