Move-In and Set-up:

-Exhibitor spaces will be available for set-up from 8am until 8pm on Thursday, March 21nd. Move-in hours will be strictly enforced for security purposes. **ALL EXHIBITORS MUST BE SET UP PRIOR TO 8PM, Thursday March 22nd, NO EXHIBITORS WILL BE ALLOWED TO SET UP AFTER 8PM. NO EXCEPTIONS!** Racer move-in starts at noon on Friday, March 23rd.
*Special arrangements for early arrival can be made by calling the Right Coast office at 800-753-3978.

-Parking/gate passes and exhibitor credentials will be issued when exhibitor arrives to check in at venue. (VENDOR VEHICLES MUST BE PARKED IN DESIGNATED VENDOR PARKING AREAS ONLY)

Vendor Info:

(2 passes - 600sf) (4 passes - 800sf and up)
Additional weekend vendor passes may be purchased at \$10 each.

-Exhibitor display and merchandise must remain within the confines of the contracted space. Distribution of literature and sales aids must take place within your assigned vendor space ONLY.

-Booth space must be used solely by the company/person and for the products and services stipulated in the rental agreement. Subletting of space by exhibitors is strictly prohibited.

-Exhibitors are required to maintain a neat and orderly appearance at all times.
